of the New Paltz Central School District Board of Education to Align the Intentions and Actions of the District with the District Mission Statement

WHEREAS, the Board of Education recognizes that steps must to be taken to align the District's actions with our Mission, Guiding Principles, and Educational Standards; and

WHEREAS, the Mission Statement of the New Paltz Central School District states, "The New Paltz Central School District exists for the children of the community. The focus of its programs and activities is the commitment to measured excellence and continuous growth and development for all"; and

WHEREAS, one of our Guiding Principles is to create a cohesive and inclusive culture PK-12 across buildings and departments; and

WHEREAS, this goal is dependent upon cooperative relationships at multiple levels of District operations; and

WHEREAS, according to Educational Standard 1.0: all policies, decisions, agreements, and procedures developed and implemented by policy makers and leadership in the New Paltz Central School District are compatible with the mission, vision and guiding principles, and enhance and assure the learning and success for all students; and

WHEREAS, according to Educational Standard 5.0: leadership within the District is collaborative, aligned with the District mission and vision, invites staff input in collegial inquiry and decision making, and promotes excellence, to enhance and to improve student learning; and

WHEREAS, according to Standard 4.0, a safe and supportive learning environment is sustained throughout the District to promote inquiry and learning for all; and

WHEREAS, the willingness to enter into collaborative problem-solving is essential to supporting the District's strengths; and

WHEREAS, involuntary faculty transfers for the 2019-2020 school year have been proposed and communicated in a volume and manner that threaten District cohesion and inclusiveness; and

WHEREAS, the proposed involuntary transfers were not planned or communicated in a manner consistent with the aforementioned goals and, if executed, may negatively impact students; and

WHEREAS, the District's Climate Survey revealed very high ratings for student-teacher relationships and school belonging at the elementary level; and

WHEREAS, these high ratings are in accordance with the Board's priority to promote student socio-emotional health, and the Board is deeply concerned that the proposed transfers threaten to disrupt that positive environment; and

WHEREAS, the Board will not abdicate their role as trustees and stewards of the District's overall well-being and as servants of the public;

NOW, THEREFORE, BE IT RESOLVED THAT: the Board respectfully requests that the Superintendent of Schools take immediate action to suspend all involuntary transfers pending Board of Education approval and enter into mutually agreed-upon mediation between the Superintendent and the New Paltz United Teachers' Union leadership, in order to realign the District culture and relationships towards communication, transparency, and mutual respect.
